2. HAZARDS IDENTIFICATION**2.1 INFORMATION and CLASSIFICATION**

Overview: This mixture is fine powder with no or slight plastic-like odor. This mixture may cause irritation of the respiratory system, eyes, and skin. This mixture, like most organic powders, can cause a dust explosion if particles form thick clouds. Acute health effects: Eye contact - Irritation may occur by mechanical abrasion; Skin contact - Minimal skin irritation may occur; Inhalation - Slight irritation of respiratory tract may occur with exposure to large amount of toner dust; Ingestion - Ingestion is an unlikely route of entry under normal conditions of use. Carcinogenicity: This mixture contains titanium dioxide listed by IARC as Group 2B (possibly carcinogenic to humans); however, no significant exposure to titanium dioxide is thought to occur during the use of the product because titanium dioxide is mostly in a bound form in this mixture.
