Protective equipment and precautions for firefighters

Firefighters must wear fire resistant protective equipment and appropriate breathing apparatus. The staff must equipment filtermask(full mask) or isolated breathing apparatus. Prevent collapse of cargo piles. Don't put the goods together with oxidizer and chief food chemicals. The transport vehicle should prevent exposure, rain and high temperature. For stopovers, the vehicle should be away from fire and heat sources.
