Description of necessary first aid measures

Methods and materials for containment and cleaning up

Small spill : Stop leak if without risk. Move containers from spill area. Dilute with water and mop up if water-soluble. Section 7. Handling and storage

Precautions for safe handling

Protect pods from freezing and overheating, avoid high humidity and outdoor storage. Store at temperatures from 50 to 80 F and relative humidity 50-60%. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers.
