# 6. Accidental release measures

## 7. Handling and storage

## Precautions for safe handling

Do not allow backfeed into the container. Purge air from system before introducing gas. Use only properly specified equipment which is suitable for this product, its supply pressure and temperature. Contact your gas supplier if in doubt. Do not re-use empty containers. Do not get in eyes, on skin, or on clothing. Avoid breathing gas, Use only in well-ventilated areas.
