**Carcinogenicity:** In 1996, the IARC reevaluated Carbon Black as a GROUP 2B carcinogen (possible human

carcinogen). This evaluation is given to Carbon Black for which there is inadequate human evidence, but sufficient animal evidence. The latter is based upon the development of lung tumors in rats receiving chronic inhalation exposures to free Carbon Black at levels that induce particle overload of the lungs. Studies performed in animal models other than rats have not demonstrated an association between Carbon Black and lung tumors. Moreover, a two-year cancer bioassay using a typical toner preparation containing Carbon Black demonstrated no association between

exposure and tumor development in rats.

STOT - Multiple Exposure: In a study of rats exposed to a toner containing Carbon Black, a mild degree of lung fibrosis was

observed in groups exposed to the high concentration (16 mg/m3) and mid-concentration (4 mg/m3), but no pulmonary change was reported in the group exposed to the low concentration (1 mg/m3). In normal conditions of use (in electro-photographic apparatus), the maximum concentration of toner released is significantly lower than 1 mg/m3, and will have no chronic

effects to human health. In cases where this product is used in bulk for purpose such as filling, cleaning, etc. of the apparatus, exposure should be controlled with care according to Sections 7

and 8.
