Usage information:

General odor control and deodorizing:

1. Add 2 ounces of Coastwide Professional 63 per gallon of water.
2. Dispense or mix with cold water according to dilution chart.
3. Apply solution to surface.
4. For best results, let air dry. This allows the product time to produce enzymes to digest unwanted odors.

Wear protective gloves/protective clothing/eye protection/face protection when handling concentrated product. Wash face, hands and any exposed skin thoroughly after handling.
